

ARTICULATION AGREEMENT
For the
PHARMD/DOCTOR OF PHARMACY
Between
TOURO COLLEGE OF PHARMACY
And
CUNY– BROOKLYN COLLEGE

I. **PURPOSE**

This document is an agreement between the Touro College of Pharmacy (TCOP) and CUNY-Brooklyn College of a contractual relationship to conduct a 7-year BS-PharmD Pathway (“the Pathway”). The agreement will become effective _____ Date

II. **ADMISSIONS**

CUNY-Brooklyn College will recruit and admit first-year students into the Pathway to follow a specific TCOP/CUNY-Brooklyn College track.

During a student’s three years at CUNY-Brooklyn College the following is required:

- A cumulative GPA of 3.0 and a science GPA of 2.75. In unique cases a lower GPA may be considered.
- Completion of a minimum of 8 credits of biology (course/lab), 8 credits **each** of general chemistry and organic chemistry (course/lab), 8 credits of anatomy and physiology (if taught combined, anatomy and physiology 1 and 2, or if taught individually, anatomy and physiology, each course to include a lab), 4 credits of physics (course/lab), 4 credits of microbiology (course/lab), 3 credits of biochemistry, 3 credits of calculus, 3 credits of economics, 3 credits of English composition or literature, 3 credits of English oral communication/public speaking/ speech, 6 credits of humanities and 6 credits of behavioral/social sciences, with no grade below C in any of these courses or labs and no grades taken earlier than 10 years ago. At least 51 of the 67 credits listed above must be taken at Brooklyn College. For purposes of meeting this requirement, only the required credits for a given course are included in the sum, not the credit count for the course (e.g. a student who takes 10 credits in organic chemistry may only apply 8 of these credits to the required 51).
- Students are encouraged to enroll in additional courses such as genetics, statistics/biostatistics, and computer science.
- At the time of enrollment in TCOP, students must have successfully completed a minimum of 90 undergraduate credits.
- A favorable recommendation by the Pre-health Advisor and 2 additional recommendations, one of which must be from a healthcare professional.
- A satisfactory personal interview by Touro College of Pharmacy faculty.
- A completed PharmCAS application.

While students meeting the above requirements are given preference in the admissions process, enrollment in the Pathway is not a guarantee that the candidate will be granted admission to Touro College of Pharmacy and final decisions will be solely at the discretion of Touro College of Pharmacy. Students enrolled in this pathway who do not meet or exceed the above standards have the privilege of applying for admission to Touro College of Pharmacy through the regular channels or procedures.

III. CURRICULUM AND ADVISEMENT

CUNY-Brooklyn College agrees to have students in the program pursue a curriculum approved by both CUNY-Brooklyn College and Touro College of Pharmacy. CUNY-Brooklyn College agrees to award a Bachelor degree to these students upon satisfactory completion of their first year at Touro College of Pharmacy, and all other bachelor's requirements. Thirty credits earned in the first year at Touro College of Pharmacy will count towards both the undergraduate and professional degrees, provided it is completed with a grade of C- or better. The usual rule requiring that the last 18 credits toward a degree be taken at Brooklyn College is waived for students who complete coursework at Touro in this fashion.

Touro College of Pharmacy agrees to provide support in evaluating and interpreting pre-pharmacy curricular requirements at the request of CUNY-Brooklyn College.

IV. SATISFACTORY PROGRESS

CUNY-Brooklyn College students accepted to complete undergraduate studies with the first year at TCOP, who fail to maintain satisfactory academic progress, will be eligible to complete the remaining requirements for the undergraduate degree at CUNY-Brooklyn College.

IV. CANCELLATION

Either party to this agreement may cancel by formal notification to be received by October 1st of any academic year, with cancellation effective at the end of that academic year. All students who are enrolled in the program at the time of such notification shall be continued in the program and shall be eligible for acceptance by Touro College of Pharmacy under the terms of the agreement.


IV. MISCELLANEOUS


