Enacts into law major components of legislation necessary to implement the education, labor and family assistance budget for the 2007-2008 state fiscal plan; relates to regents standards and academic performance; designates a member of the board of regents to serve on the New York state cultural education trust; relates to funds provided to the city school district for the city of New York for teacher resource and computer training centers for the 2006-2007 school year; authorizes the commissioner of education to expend money
