Enact Local and State CRC Resolutions

Even though treaties have to be ratified by the US Senate, working to pass local or state resolutions provides individuals an opportunity to:

- directly influence local and/or state policymakers and elected officials
- educate and raise awareness about the CRC at the local and state level
- engage, outreach and work alongside local and state professionals, organizations and

Where have CRC Resolutions been Enacted?

- Missouri Gov. Bob Holden issued a Proclamation on the CRC on Sept. 14th, 2004
- Rhode Island adopted a House Resolution on the CRC in January 1990, 1999, and 2002
- Oklahoma adopted both a House and Senate CRC Resolution in May 2009
- New York City adopted a CRC Resolution unanimously in 1989
- Chicago, IL adopted a CRC Resolution in Feb. 2009
- San Francisco, CA adopted a CRC Resolution in April 2009
