# High-Level Panel Discussion on Prevention of and Responses to Violence Against Children Within the Juvenile Justice System

The Special Representative of the Secretary-General (SRSG) on Violence Against Children, Marta Santos Pais, the United Nations Office on Drugs and Crime (UNODC) and the Office of the High-Commissioner for Human Rights (OHCHR) organized a high-level panel discussion on October 8th, 2012. Chaired and supported by the governments of Thailand and Austria, this event aimed to strengthen the protection of children from violence against children within the juvenile justice system and to prevent the occurrence of incidents of violence against children. Speakers included Ms. Anne Brita Normann, Senior Adviser at the Norwegian Ministry, Ms. Elda Moreno, head of the Gender Equality and Human Dignity Department, Council of Europe and Mr. Phelan Wyrick, Senior Advisor in the US Department of Justice. SRSG Marta Santos Pais and Dr. Phelan Wyrick - who had been delegated by the U.S. Department of Justice to represent, as Luncheon speaker, U.S. Attorney General Holder's national initiative of Defending Childhood from Violence - participated with many other esteemed speakers at our Children's Studies Center's 20th Anniversary National Consultation event, Social Justice for Children: To End Violence Against Children. This event was held at the Association of the Bar of the City of New York on November 4, 2011. The event aimed at drawing attention to the prevalence of all forms of violence against children and their maltreatment in the United States. Discussions touched on the critical dimensions concerning the widespread use of violence against children, and ways of effectively preventing it from occurring in various situations, including in the home, in schools, in child protection systems, in juvenile/criminal justice systems, in health and mental institutions and in other social settings.
