- ✓ Must be registered for at least six (6) credits within your division
- ✓ Must be a matriculated Student
- ✓ Must have completed an Entrance Counseling online at studentloans.gov
- ✓ Must attach a copy of the Entrance Counseling confirmation page with this application
- ✓ All graduate students must check unsubsidized, as subsidized loan are not available for graduate students

If a Direct Loan application is received with any missing information, your application will be returned.

After you submit the Direct Loan application with an Entrance Counseling confirmation page:

- ✓ Must sign Master Promissory Note (MPN) studentloans.gov

Please note that if you have signed your MPN within the last ten (10) years and have received a Direct Loan disbursement within the last one (1) years you DO NOT need to sign it again.
