- ✓ Must be a matriculated Student
- ✓ Must have completed an <u>Entrance Counseling</u> online at <u>studentloans.gov</u>
- ✓ Must attach a copy of the Entrance Counseling confirmation page with this application
- ✓ All graduate students <u>must</u> check unsubsidized, as subsidized loan are not available for graduate students

If a Direct Loan application is received with any missing information, your application will be returned.

After you submit the Direct Loan application with an Entrance Counseling confirmation page:

✓ Must sign Master Promissory Note (MPN) <u>studentloans.gov</u>

<u>Please note that if you have signed your MPN within the last ten (10) years and have received a Direct</u> <u>Loan disbursement within the last one (1) years you DO NOT need to sign it again.</u>
