WILLIAM D. FORD FEDERAL DIRECT PARENT PLUS LOAN PROGRAM

The Federal Direct PLUS Loan is a low-interest, credit based program that allows parents of dependent undergraduate students to borrow money to help pay for educational expenses. A parent can borrow up to the cost of education minus any other financial aid received.

The current interest rate for Federal Direct PLUS Loans is currently fixed at 7.00%*, with an origination fee of 4.26%*

*Please note the interest rate and origination fees are subject to change

The Following requirements must be met before submitting a Parent Plus Loan Request:

***If we receive a Parent Plus Loan Request with one of these requirements missing your application WILL BE RETURNED. ***

- ✓ The student must File a 2018-2019 FAFSA
- ✓ The student must have completed all "To Do" items on CUNYfirst
- ✓ The student must be registered for at least six (6) credits within their division
- ✓ The student must be matriculated

After the Parent Plus Loan is Requested:

- ✓ The Parent must sign a Master Promissory Note (MPN) under their name at Studentloans.Gov
- ✓ Parent must be approved a credit check

If the Parent Plus Loan is Denied:

- ✓ Contact the Department of Education to request a review of the credit check. There may be inaccurate information on the applicant's credit report. This information will be included in the letter of denial
- ✓ Parent may seek an endorser
- ✓ The student **may** be entitled to additional unsubsidized loans
