<b>HIGH RISK LOCATIONS/RISK FACTORS</b>	
<b>Description of Identified Risk Factors</b>	<p>Brooklyn College invited representatives from each union to participate in a physical site evaluation of the campus on January 13, 2013 and May 9, 2013. Factors that might place an employee at risk include but are not limited to:</p> <ul style="list-style-type: none"> <li>• Offices that handle the exchange of money, including cash, checks, money orders, and credit card receipts: Enrollment Services Center, Performing Arts Center, and Central Routing Mail Room.</li> <li>• Offices that handle issues stressful to students, such as the Counseling Center, Enrollment Services Center, Academic Advising Offices, Office of Services for Students with Disabilities, Office of the Deans, Library and Library Café.</li> <li>• Offices that handle issues stressful to faculty and staff, such as the Office of Human Resources.</li> <li>• Work sites containing employees who work alone or in small groups: academic offices, faculty offices, entire campus for custodial staff, media technicians, IT support.</li> <li>• Work sites containing employees who work late at night or early in the morning or on weekends; Entire campus for custodial staff and Public Safety staff, Library faculty and staff, faculty.</li> </ul>

Bullet Proof Glass (ESC), Safes (ESC, Performing Arts Center, and Central Routing)</li> <li>ii. Card Access.</li> <li>iii. Outside Events – Metal Detectors. (Student Control)</li> <li>iv. Video Cameras – Some Outside and Interior Locations.</li> <li>v. Emergency PA System Throughout All Campus Buildings.</li> <li>vi. Security Mirrors.</li> </ul> </li> <li>b) Administrative or Work Practice Controls.             <ul style="list-style-type: none"> <li>i. Sign-in/Sign-out procedure for off-hour access.</li> <li>ii. Vertical Patrol rounds.</li> <li>iii. Notifications to Public Safety.</li> <li>iv. Posted Office Hours.</li> </ul> </li> <li>c) Personal Protective Equipment (PPE).             <ul style="list-style-type: none"> <li>i. Walkie-Talkies (Public Safety/ Buildings &amp; Grounds).</li> <li>ii. Cell Phones</li> <li>iii. Emergency Contact for Public Safety from any phone on campus.</li> <li>iv. Panic Buttons. (ESC Center; Administrative Offices).</li> <li>v. Posted Phone Numbers for Public Safety Emergencies and NYPD for Cell Phone use.</li> <li>vi. Assigned NYPD Patrol Officer.</li> </ul> </li> </ul>
